I hereby declare: that I am eligible to represent my YMCA, according to the Rules that Govern Competitive Sports (11/96) and the Rules for the 2011 NATIONAL YMCA LONG COURSE SWIMMING CHAMPIONSHIP.

- that I am an amateur.
- that I have not represented a junior college, college or university in formal swimming competition.
- that I am a full privilege annual member of my YMCA and have been for 90 days prior to the championship meet.

Have participated in three (3) closed YMCA interassociation meets which must have been contested on separate dates plus one closed National YMCA Sanctioned Cluster, District, Satellite, State, Area or Regional YMCA Championship meet. 
