

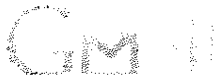

I hereby declare that I am eligible to represent my YMCA, according to the Rules that Govern Competitive Sports (11.86) and the Rules for the 2011 NATIONAL YMCA LONG COURSE SWIMMING CHAMPIONSHIP.

- that I am an amateur.
- that I have not represented a junior college, college or university in formal swimming competition.
- that I am a full privilege annual member of my YMCA and have been for 90 days prior to the championship meet.
